## Q11

Heat Vulnerability: Large sections of Moreland's north are at the extreme end of the Heat Vulnerability Index, meaning residents are very susceptible to global warming. What will you do to address this beyond existing policies, including Moreland Urban Heat Island Effect Action Plan (Word Doc 48MB), Moreland Urban Forest Strategy 2017-2017 (PDF 9MB), Cooling the Upfield Corridor Action Plan?

Not only is climate change an emergency, it is also a health emergency. Rising temperatures and heat are increasingly taking people's lives and harming people's health. My day job is at the Climate and Health Alliance (CAHA), a non-profit working to build a powerful health sector movement for climate action and sustainable healthcare.

Through my work at CAHA, I hear the stories (and the statistics) of people who have lost their lives through climate health impacts, including one emergency physician's story of seeing an elderly woman in Brunswick lose her life following a period of extreme heat.

Acting on the climate (health) emergency will be one of my top priorities if elected to Council.

If elected, I, along with my fellow Greens Councillors, will have acting on the climate (health) emergency as one of our top priorities. We will work to cut emissions by: ensuring zero Moreland community emissions by 2040; promoting more environmentally sustainable design and construction; supporting the rapid transition to renewables, including further exploring and supporting community-owned renewables; investing in more active transport infrastructure; strongly advocating for more and better public transport in Moreland; more support for community members to access energy efficient and low-emissions technologies; moving towards a zero-waste, circular economy; and educating the community about the impacts of the climate emergency to encourage individual behaviour change. We'll work to draw down more carbon by creating new parks and open spaces, and planting even more trees across our city, which will also help tackle the urban heat island effect. And we'll do much more!

## Q12

Waste Management. Moreland aims to be a leading council in sustainable waste management, yet its rate of diverting waste to organics and recycling sits just above the state average. What will you do to help Moreland in the rollout of the Food and Garden Organics Collection Service, and achieve Moreland's 2030 zero waste to landfill target as part of Zero Carbon in the Planning Scheme – ESD Policy v2.0?

The waste strategy is running behind schedule, with the plan now being to roll out the new FOGO (Food and Garden Organics) collection service by early 2022. This plan factors in the need to include a new glass bin option, which will be required in coming years by the Victorian government. Greens Councillors will push Council to meet or beat its current deadline.

## Q13

Energy Efficiency and Renewables. Moreland has a goal of "Efficient and 100% renewably powered energy". Yet Moreland has one of Victoria's lowest uptake of solar PV. How can Moreland "walk the talk" on renewable energy and meet the community goals set in the Zero Carbon Moreland – Climate Emergency Action Plan 2020/21 – 2024/25?

To further cut emissions, as the climate emergency demands, I and Greens Councillors will work to ensure Council supports the rapid transition to renewables, as well as the uptake of energy efficient technologies and measures, in Moreland.

We support continuing Council allocating funding for low income households to install solar and energy and thermal efficiency upgrades. We will explore further ways to support more renewables in, and for, Moreland. And we will advocate to State government for further support for renewables, in our city and across the state.

## **Q14**

Pollution and litter: How will you educate and incentivise business in industrial zones (especially in the North East Ward) to avoid pollution and litter from entering our drains and our creek systems?

The Greens will explore any levers that Council can use to encourage businesses and industries to do the right thing, without relying heavily on punitive measures.

Moreland does not have its own waste recovery site within its boundaries. The city relies on other Councils to provide this service and on private waste transfer sites. The federal and state governments have the resources and powers to introduce measures of this size and importance.

Land, like Kangan TAFE, is expensive and not part of Councils assets. Were the Vic Government open to a partnership to utilise this facility to support sustainable industries, the Greens would be eager to explore this and support such an outcome, or similar. The Greens also want more on-ground signage indicating that what goes down the drain or street ends up in our waterways and our bay/oceans. People need to know that their actions and inactions have a wider impact. This should be combined with more support for community education programs around plastics, micro-plastics and their impacts.

## **Q15**

Supporting business and the environment as part of Covid Recovery What actions will you take to help Council promote environmentally sustainable jobs as part of a Covid recovery such as by possible development of large abandoned sites for a sustainability hub (such as former Kangan TAFE automotive campus)? How else will you advocate for supporting small business Covid recovery that includes environmental co-benefits?

With Australia now in recession and Victoria still in strict lockdown, all levels of government are working out how they can best create and protect jobs and stimulate the local economy.

One of my top four priorities is utilising any opportunities presented through the COVID economic recovery period to support Moreland households, businesses and community groups through measures that have environmental and health co-benefits by acting on the climate emergency through cutting emissions, drawing down carbon and building climate resilience. This means, for example, accelerating the roll out of active (and public) transport infrastructure, new parks and open spaces, and community programs and services in Moreland.

The Greens back the move at a special Council meeting 21 September to support funding for outdoor dining and related initiatives, including using car spaces and vacant land to facilitate eateries as they re-open, as the virus spread is brought under control.

Additionally, the Victorian Greens are calling on the Victorian Government to invest in COVID recovery plans that include shopping strip renewals and shopping locally and in 23 new or expanded recycling factories by 2025 to meet the state's needs and ensure high recycling rates and new jobs (with ideally Moreland or the region to host one of these recycling factories).

## **Q16**

Food Security How would you address food security in Moreland beyond the existing Moreland Food System Strategy? (including as a part of the clean Covid recovery)?

Over the previous term, under Councillor Natalie Abboud's leadership, the Greens Councillors drove the updating of the Food Systems Strategy.

Greens Councillors will follow up Councillor Jess Dorney's recent work to facilitate nature strip and laneway options for greening and food options. Greens Councillors will continue to support and resource the establishment of new community garden spaces and nature strips across the city, and seek to provide further support for the Northern Food Community Hub.

We will also advocate for additional funding of the Moreland Nature Plan to ensure it meets its goals, includes food production and that species are protected and saved.

Buildings, Biodiversity and Urban cooling: What would you do as a Councillor to ensure that with new building developments, Moreland has sufficient vegetation cover to contribute to biodiversity outcomes and urban cooling beyond existing policies in the Urban Forest Strategy, Moreland Nature Plan, and the Achieving Zero Carbon in the Planning Scheme – ESD Policy v2.0 project?

Greens on Council will work to: Plant more trees in Moreland, including by advocating to properly fund the Moreland Nature Plan so it meets its goals; Ensure that the ESD Policy 2.0 project is undertaken, monitored and then approved quickly by the Planning Minister; Continue to promote the nomination of additional trees to the Significant Tree Register; Look to further support the Urban Forest Strategy to meet the targets or stretch (where additional resources can be found); Allocate more resources for community education on the benefits of trees and tree cover, and the extent of the loss of trees in the private realm and its impact; and Explore with the community other measures to reach these goals.
