Nevertheless, medium and high-density blocks are often excluded from council organics waste services. Given this, I plan to investigate possibilities for tailored waste management for medium and high-density residential developments. Such as providing composting systems or tailored food waste collection. Furthermore, given there continues to be a high level of contamination in Merri-bek's recyclables stream it is also clear that further community engagement and education around waste management is required.
